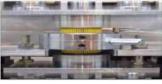


**Kapuk Plant (Radiator Facilities)**

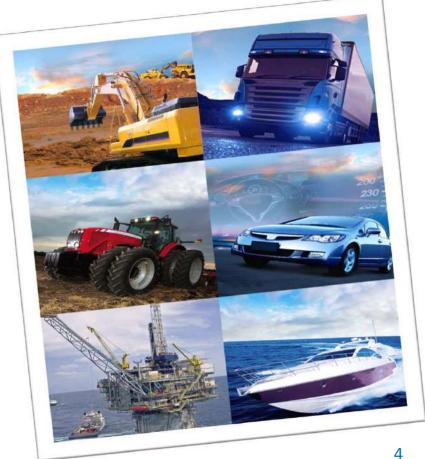

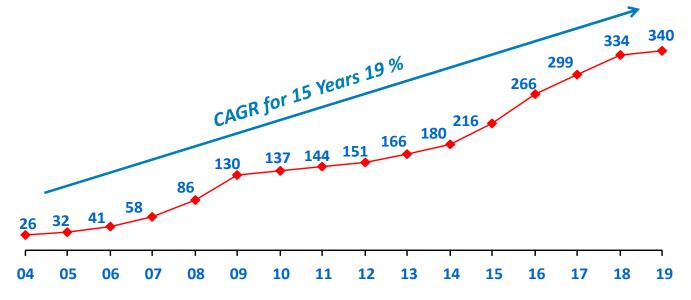

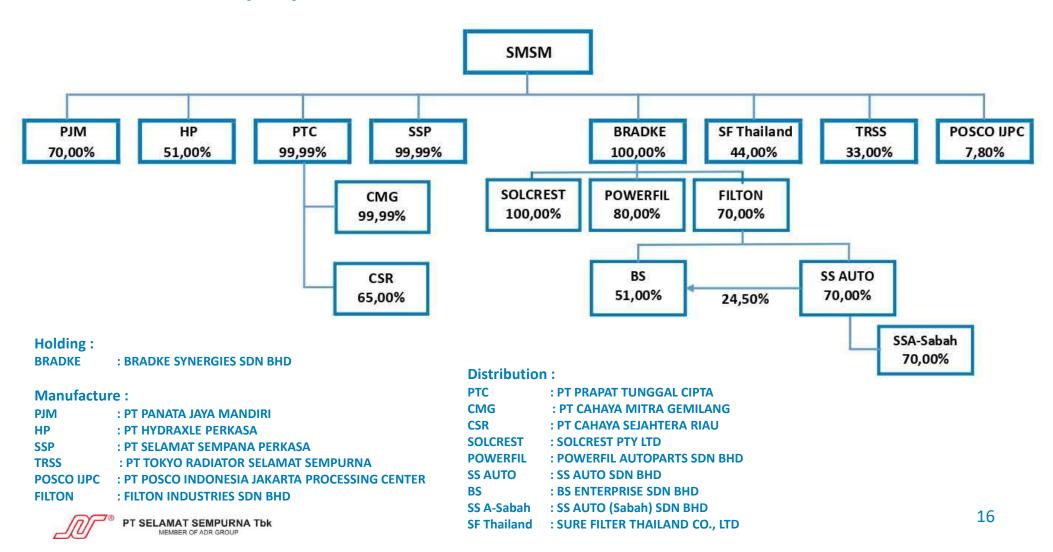
