Merujuk pada ketentuan III.1.1.4. Peraturan Bursa Efek Indonesia Nomor I-E tentang Kewajiban Penyerahan Informasi, Perseroan menyampaikan penjelasan atas perubahan lebih dari 20% pada total liabilitas dalam Laporan Keuangan Interim per 30 Juni 2026 dibandingkan dengan Laporan Keuangan Tahunan Auditan per 31 Desember 2025 sebagai berikut:

With reference to Provision III.1.1.4 of Indonesia Stock Exchange Regulation Number I-E concerning the Obligation of Information Disclosure, the Company hereby submits its explanation regarding the change of more than 20% in total liabilities as presented in the Interim Financial Statements as of 30 June 2026 compared to the Audited Annual Financial Statements as of 31 December 2025, as follows:

Peningkatan total liabilitas Perseroan terutama berasal dari Utang Dividen, yang tercatat sebesar Rp219,77 miliar pada 30 Juni 2026 atau meningkat sebesar 100% dibandingkan posisi 31 Desember 2025. Peningkatan tersebut terutama disebabkan oleh pengakuan kewajiban atas dividen final Tahun Buku 2025 yang telah memperoleh persetujuan dalam Rapat Umum Pemegang Saham Tahunan (RUPST) pada tanggal 5 Juni 2026. Mengingat pembayaran dividen final dilakukan pada tanggal 2 Juli 2026, maka sampai dengan tanggal 30 Juni 2026 dividen tersebut masih dicatat sebagai Utang Dividen dalam laporan keuangan Perseroan.

The increase in the Company's total liabilities was primarily attributable to Dividend Payables, which amounted to IDR219.77 billion as of 30 June 2026, representing a 100% increase compared to the position as of 31 December 2025. This increase was mainly due to the recognition of the obligation relating to the final dividend for Fiscal Year 2025, which was approved at the Annual General Meeting of Shareholders (AGMS) held on 5 June 2026. As the final dividend was payable on 2 July 2026, it remained recognised as Dividend Payables in the Company's financial statements as of 30 June 2026.

The Board of Directors believes that the increase in the Company's total liabilities as of 30 June 2026 does not have a material impact on the Company's performance or its ability to meet its obligations. This is reflected in the Company's Liquidity Ratio and Debt to Equity Ratio [DER] as of 30 June 2026, which remained at a healthy level, i.e.:
